**Review of Minutes: Ron entertained a motion to accept the minutes as written. (November 21, 2016) Brian made the motion and Ron second the motion. The motion passed. **Regarding November 28, 2016 minutes a motion was made by Steve that the Selectmen correct the minutes from the November 28th meeting, regarding the Emergency Management Director's term of office as ending December 31, 2016 and that the Selectmen vote to relieve Christine Spaulding of her position effective December 31, 2016. Ron second the motion, motion made and carried. All in favor.

**The correction minutes were accepted and to be put on file. Brian made the motion to accept and Steve second the motion. All were in favor.

Fire Chief: Jim Waterman reported that he will be delivering 25-26 Christmas Baskets on the 17^{th to} the needy. Jim still has a job for K & T regarding the pullout drawer for the truck generator. It's been done for several months but they haven't been down yet to install it. There will be a meeting on the fourth Tuesday in January. Jim will be given a key to have access to the generator.

Town Clerk: A man stopped by the office and presented Cindy with three laptop computers as a gift from Mount View, through the I.T Program. It was requested that the committee reports should be turned in by February 6 so that they can be included into the town report which will be printed two weeks prior to March 11, the day of the Town Meeting.
