- Ken wrote up a letter and reviewed with selectman to send to residents about changes.

OLD BUSINESS:

- Went over Petition submitted by Bob Gerrish for winter maintenance of Deer Hill rd. It is a legal petition. Ron motioned to accept the petition for Deer Hill rd. Ken seconded. (All in favor)
- Steve reported that the one lot on the west side of Mitchell rd. is not owned by the town however the dump lot and adjoining lot on east side is. He also found that the

town does own the 44 acre lot called the "Old dump" on 137 they just need to find the deed for it.
