CALL TO ORDER:

Selectman Ron Price called the meeting to order at 6:15 p.m. Those in attendance were: Selectman Steve Bennett, Selectman Brian Jones, Clerk Cindy Abbott, Treasurer Erna Keller, Secretary Sallyann Hadyniak, Marilyn Perry and Jim Waterman.

REVIEW OF MINUTES:

TREASURE'S REPORT:

**Brian made a motion to approve both the Payroll warrant in the amount of \$5,123.59 and A/P warrant in the amount of \$55,708.99 and the second A/P in the amount of \$10,848.00. Steve second the motion and all were in favor.
