- Ron- According to Coughlin last night, he said that back in 2003 the town had started the process. The discussion was where to have it. Different locations such as dump road and corner of Mitchell and Belfast Road. They was decided against because of the cost to move and rebuild in a new area. So the foundation was laid back then and has been back and forth for years. We need to rectify this situation, make a plan, stick to it and take action.
